## GENERAL DATA PROTECTION REGULATION (GDPR) DATA HANDLING AGREEMENT

### Purpose

The Cyprus Study Circle will use and hold the personal data you have supplied for the purposes of organising the running of the Study Circle, providing services to the membership and promoting the Study Circle.

Please note the following specific data handling instances:-

(a). **Members who receive printed copies of the CCP, Auction Lists etc:** For each issue our Printer stuffs the envelopes and posts them out to our members for us. To allow him to be able to do this the Study Circle provides the Printer on each occasion with the correct number of self adhesive printed address labels.

(b). **On the very odd occasion when an Auction House has a major auction sale of Cyprus material they may ask the Study Circle if they can send a copy of the auction catalogue to each of our members.** In the event that the request is agreed to, the Study Circle then provides the Auction House with a set self adhesive printed address labels which is on the understanding that they are ONLY used for the purposes that they are supplied for (ie: sending just the specific auction catalogue or catalogues if the sale comprises more than one catalogue). (c). **UK members only who take the Study Circle Packet:** These members should note that their name, address and telephone number is included on the packet circulation list which each member on the list sees.
